On September 13th at 4:15pm, Ruben Campuzano of Elgin decided to ram into a Trike sitting at the stop light at 25 and Gilbert Street in St. Charles ridden by a 72 year old man. The Trike basically exploded and Campuzano sped off and the rider went to the hospital in critical condition. Campuzano was arrested by the Kane County Sheriff's Office on September 18th and he admitted to not stopping because he did not have a drivers license. Campuzano has been charged with Failure to Report an Injury Accident, a Class 2 Felony; Aggravated Reckless Driving, a Class 4 Felony; and Driving While License Suspended – second offense, a Class 4 Felony. THIS CAN NOT STAND! We preach the message of Start Seeing Motorcycles and then this happens. This is where we need to stand together as a brotherhood and let everyone know we will not tolerate things like this. I will be calling for court watchers and more as we need to enforce this message!

On another sad note, I send my condolences to the family of DuKane Member Lee Noble who was tragically taken from us in a motorcycle accident in Aurora. The BOD voted unanimously to give \$500 to the family from the DuKane Downed Rider Fund.

Legislative Coordinator Randy Ramey and myself attended an event on September 21st for Illinois State Senator Karina Villa. This event was also attended by Illinois State Representative Maura Hirschauer. There was great talk about the latest language from Governor Pritzker's Office – mainly Deputy Governor Christian Mitchell – that they don't consider motorcycles primary modes of transportation in Illinois and specifically excluded EV Motorcycles from the Electric Vehicle Designation and Incentives in Illinois (See Randy's Article for more on this). Both the Senator and Representative agreed that a trailer bill is needed to ensure EV Motorcycles are included. We thank them for their time. Hello All,

To finish the session, the legislature went back and passed the Energy Bill that took 2 years to negotiate. A last minute addition included infrastructure and rebates for electric vehicles. The important part of this for ABATE is that it specifically removed electric motorcycles from the definition of electric vehicles. The Governor went ahead and signed the bill despite many calls to change the language. The silver lining here is that the sponsor of the bill has said on the record that there will be a follow up or "trailer bill" to fix the language. I have it on good authority that the language in being written and that DuKane ABATE friend Senator Tom Cullerton will be carrying the bill when it is introduced in the spring session.



It will be important that you reach out to your Senator and Representative to ask for their support of this legislation. When a bill number is provided I will get that out to all our members. A few of these legislators will be attending our 35th Annual Toy and Food Drive. It is also important that you understand that we get support from both sides of the aisle. As long as they are voting for motorcycle rights we should refrain from political arguments on philosophy and thank them for their continued support.

Spring session will start in the end of January, 2022 but looks to be a light session. This means less bills will be introduced. The primary is in June so they will not be wanting to hang around Springfield for too long. As legislation develops, you will be informed of the issues that affect riders in Illinois.



Hey, everyone,

Due to some of the legislation in Illinois, I've got a little project to advocate for a change to said legislation. There is an Illinois bill, SB0018, that relates to energy plans for our state. One topic relating to energy plans is electric vehicles, a category into which some motorcycles should fall. But the writers of this legislation don't seem to think so, as shown in the following excerpt from Illinois general assembly website:

"Electric vehicle" means a vehicle that is exclusively powered by and refueled by electricity, must be plugged in to charge, and is licensed to drive on public roadways. "Electric vehicle" does not include electric motorcycles or hybrid

electric vehicles and extended-range electric vehicles that are also equipped with conventional fueled propulsion or auxiliary engines.

We're hoping to change politicians' minds relating to this definition, because there are street-legal motorcycles that only run on electricity. As such, we are sending the message that motorcycles are primary vehicles of transportation and that electric motorcycles should be classified as electric vehicles in this sort of legislation. To that end, I will be gathering pictures of motorcycles under the hashtag #motorcyclesareprimary to publish on social media so that these lawmakers will know that they need to rethink their definition of an electric vehicle. So post pictures under #motorcyclesareprimary, and we may very well use them to promote this legislative change.




