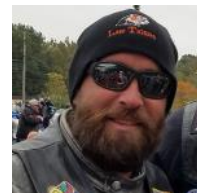
The ABATEPAC and FEDPAC grading sessions happened on April 9, 2022 and I was in attendance as a trustee on both PACs. Many things were



discussed via surveys with candidates for local, state, and federal races. Topics included ethanol, motorcyclist profiling, freedom of helmet choice, off-road motorcycle and ATV issues, autonomous vehicles, EV Motorcycles, and more! The candidates were graded by their responses and how they've stood with A.B.A.T.E. in the past. Endorsements were also decided.

We'd like to congratulate Kane County Sheriff Ron Hain, Candidate

for Congressional IL03 Justin Burau, and Gubernatorial Candidate Darren Bailey for receiving endorsements from A.B.A.T.E. of Illinois PAC and FEDPAC in the 2022 Primary Election! These are very well deserved as these gentlemen have been active in learning our issues and working for motorcyclists!



One topic that needs to be discussed is motorcyclist profiling. This is happening in our area, and it cannot be put up with it. Businesses like H-D Rockers in Maple Park and The Town Bar & Grill in Aurora have made it abundantly clear that they are not allowing cuts/colors/clubs. Judging someone based on what is on their vests is unacceptable and we cannot stand idly by while it happens. But the topic and business we want to cover is Brauer House in Lombard, IL. They are running Bike Nights and the business is making a profit off motorcyclists. Now, there is nothing wrong with this as many businesses and dealerships run a Bike Night doing the same thing. However, the difference is that on the flyer for said Bike Night, Brauer House is also saying "Sorry Club Members, no three-part rockers or rags". Brauer House is blatantly profiling motorcyclists on this flyer while promoting a biker event. To make things worse, we have made attempts with Brauer House to rectify this situation and have been given numerous stories. First, it was said that this was a Village of Lombard ordinance. This is 100% untrue and when Village President Keith Giagnorio was asked about it by Knucklehead Bob, Keith replied, "I've never even heard of such a thing." Then it changed to Brauer House never had issues with clubs, but they want to keep their events safe, so they want to keep motorcycle clubs out so it stays that way. Then it changed to the business partner is terrified of motorcycle clubs and doesn't want them there. She has let them into her other businesses and supposedly it has "compromised her other businesses by allowing them there". Then it changed to Brauer House has had issues with clubs and they no longer want them there.

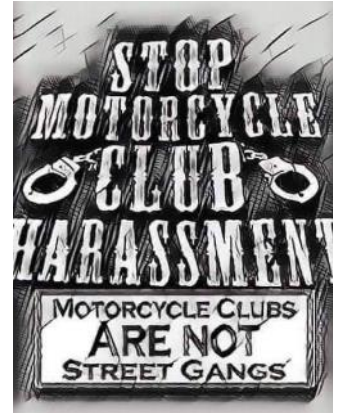

# Vice President/Legislative Rep.; Randy Ramey

Hello All!

SB 2940 has been sent to the Governor. He has 60 days to sign it, veto it or it automatically becomes law. With all the support, I don't see how he cannot sign it but I'll bet it will be low key. Here are the other items that have come out of Springfield, thank goodness they are out of session:

## GOVERNOR'S HIGHLIGHTS:

Governor Pritzker joined Democratic legislators this week to highlight the FY 23 budget's investment in youth development programs.



**Housing Assistance:** Homeowners who have fallen behind on monthly mortgage payments and/or related housing expenses as a result of the COVID-19 pandemic can apply for financial assistance through the Illinois Homeowner Assistance Fund. Struggling homeowners will be eligible for up to \$30,000 in free assistance to pay past due mortgage payments, property taxes, property insurance, and delinquent homeowner and/or condo association fees. Homeowners in need of assistance can find more information on program eligibility and begin an application at [www.illinoishousinghelp.org](http://www.illinoishousinghelp.org). Applications will be accepted until 11:59 p.m. on Tuesday, May 31, 2022.

**Broadband:** The Illinois Department of Commerce and Economic Opportunity announced the second cohort of the Regional Engagement for Adoption + Digital Equity (READY) program. Through Broadband READY, five regional entities have been selected to receive a total of \$250,000 to support planning, research, and data collection as they work to eliminate the digital divide. Broadband READY grants empower regions to explore opportunities for equitable advances in the areas of broadband access, adoption, and utilization. Each grantee will create deliverables that provide a comprehensive assessment of the broadband landscape in their respective region, which will guide program integration and resource investment to close gaps in broadband equity and inclusion.

Five institutions were each awarded \$50,000 to conduct research and outreach on digital equity:

- Bloomington-Normal EDC (North Central Region)
- Chicago State University (Northeast Region)
- Northern Illinois University (Northwest Region)
- Southern Illinois University Edwardsville (Southwest Region)
- Western Illinois University (West Central Region)

**COVID-19 Update:** On Thursday, the Illinois Department of Public Health issued a warning that COVID-19 case rates are slowly rising in many areas of the state and cautioned the public to pay close attention to conditions in their local communities and stay up-to-date on their vaccinations.

The Illinois Department of Public Health adopted [new federal guidelines for tracking COVID-19](#) at the community level. The new CDC guidelines emphasize the case rate and hospitalizations in order to better track the prevalence of COVID-19 in communities. As a result of these new guidelines, testing providers will no longer be required to report some negative tests and IDPH will therefore no longer report test and case positivity.

In addition to adopting new CDC guidelines, IDPH is bolstering the data on its COVID-19 dashboard to provide additional information to help communities respond to changes in the course of the virus.

Among the new data that has been or will be shared on the [IDPH COVID-19 dashboard](#) are:

- Updated data on vaccination rates to reflect the full population eligible as eligibility continues to evolve.
- The number of people admitted to the hospital with a COVID-19 diagnosis.
- More detailed data on hospitalizations, including information about vaccination status in those who are hospitalized.

## 102<sup>nd</sup> Illinois General Assembly:

Following a marathon week of session last week, the Illinois General Assembly stands adjourned to the call of the Senate President and Speaker of the House. In total, the General Assembly passed 407 bills (231 House Bills/176 Senate Bills) during the 2022 spring session. The chamber of origin has 30 days from the date of passage to advance bills to the Governor's desk. The Governor has 60 days to act on the legislation once it reaches his desk. If he fails to act within that time frame, the legislation will automatically become law.

The dates for the fall Veto Session are not yet set. Traditionally, both chambers release their fall veto session calendars at the conclusion of the spring session, but leaders broke with that tradition this year. We will continue to monitor for its release, but expect veto session to occur after the November 8<sup>th</sup> General Election.

Both the budget ([HB0900](#)) and the budget implementation Bill ([HB4700](#)) have officially been forwarded to the Governor's desk.

The House Tourism Committee will hold a hearing on April 20, 2000 at 1:00 pm to discuss the Ticket Sale and Re-sale Act and [HB5444](#) (Zalewski).

The more significant item to report is our transition to Old Second National Bank from West Suburban Bank. They probably could have made it more tedious and secure with more e-mails and booklets to authorize and read, but I believe everything is needed and it appears they're doing it step-by-step without much problem – that's a good thing.

The corporate account transition, as we have for DuKane Abate, is more complex than a personal account. I have a personal account and that transition happened without a hitch. The transition of our three accounts is not yet 100% complete, but I expect it to be by the time you're reading this blurb.



The scope of our transition includes web and mobile access for our three accounts, General, Toy & Food Run, and Downed Rider; Debit cards for four board members, and eventually reprinting of checks, deposit slips, etc. I will then ensure our transactions and statements sync with our last West Suburban Bank statements.

Reading over the transition information, it appears there should not be any charges or service fees that are different from what are currently encountering or would expect to pay if we had to use other services. West Suburban Bank essentially had no service fees for normal maintenance of our accounts and I expect business with Old Second, or O2 Corporate as it's called, to be the same.

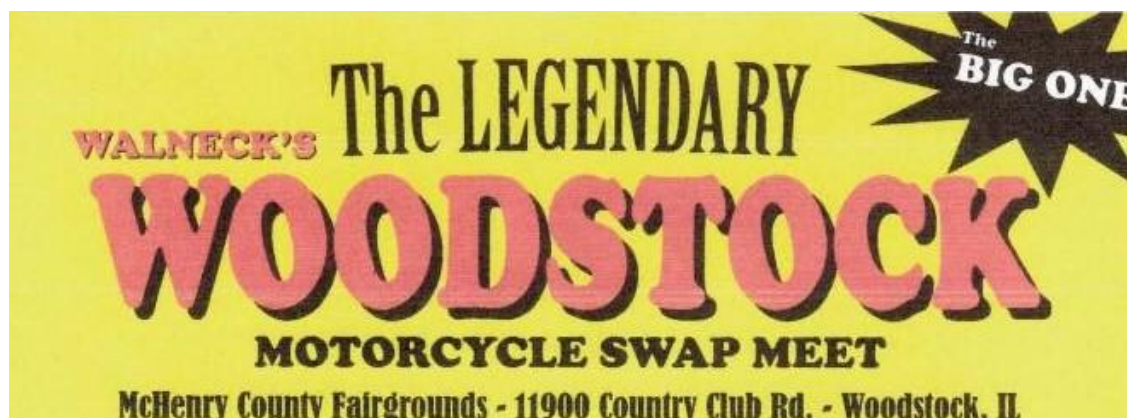

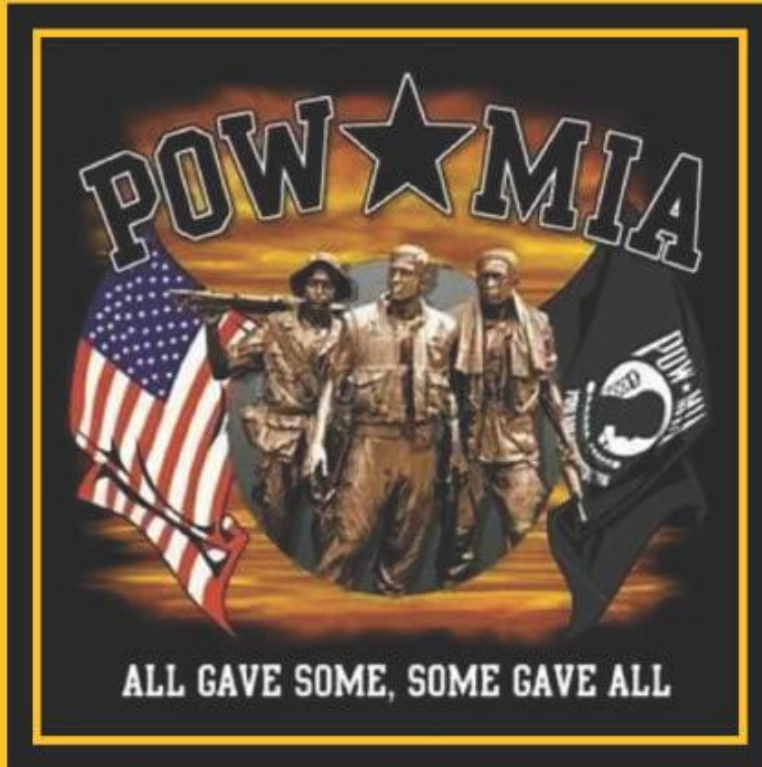
